Cares Act Report

Aug. 19, 2020

1. Jacksonville College signed the Cares Act Agreement and Certification on May 22, 2020.

2. Jacksonville College received \$ 141,902.00 of Emergency Financial Aid Grant Money for students.

3. As of Aug 19, 2020 Jacksonville College has received 149 Cares Act applications. Twenty-nine of those were not title IV qualified. We have thus far processed \$ 86,997.00 to those students who qualified.

4. Jacksonville College estimates that 200 students could be eligible to participate.

5. As of July 19, 2020, sixty-seven <u>Jacksonville</u> College students have received Emergency Cares Act Aid The highest amount given is \$3000.00, with the average amount being \$1298.16

- e. Review of all applications every 30 days.
- f. Awards to students every 30 days, based on criteria.

This financial support is for food, housing, course materials, technology, student services, tutoring, and various other needs as prescribed in our grants. The financial assistance funds are limited, so the first applicants to apply will be the first to be considered.

The amount of financial assistance that can be awarded is based on the needs of the student and the available funds of Jacksonville College.

Financial assistance awards will be dispersed to eligible applicants by September 30, 2020.
